Business:

1. November 2021 Financials: The Trustees were presented and reviewed the Financial Reports for November 2021. Upon completion of review, Rillo made a motion to accept the November 2021 Financials as presented with a second from Dusi. Ayes: Rillo and Dusi. Noes: None. Absent: Leon.
2. PJD Landscape requests Compensation Increase: The Trustees reviewed the submittal from PJD Landscape requesting an increase of \$350.00 per month as their last increase was in 2017.
