Present: Cemetery Board of Trustees – Rick Dusi and Beverly Rillo. Absent Nick Leon

Also in attendance: Sandy Cowell-Manager.

Public Comment: None at this time.

Consent Agenda: Dusi made a motion to approve the June 17th, 2021 Minutes as presented. The motion was seconded by Rillo. Ayes: Dusi and Rillo. Noes: None, Absent Leon.

Lawn Section – Plots Total 1287 Available 234, ½ plots – 6

New Lawn Section – Plots Total 231 Available 213, children sect – 8

Columbarium- Niches Total 496 Available 455

Business:

1. June & July 2021 Financials: The Trustees reviewed the financials and expenditure reports for June and July 2021. There being consensus to approve, Dusi made a motion to accept the June and July 2021 Financials as presented. The motion was seconded by Rillo. Ayes: Rillo and Dusi. Noes; None. Absent: Leon
2. Discussion regarding a Title for the Memorial Wall Monuments: The Trustees discussed and decided upon having “Memorial Wall” engraved at the top of the two front panels of the monuments facing the driveway. Engraving will take place in November. Rillo made the motion with Dusi seconding the motion. Ayes: Rillo and Dusi. Noes: None. Absent: Leon.
3. Trustee Comments: Rillo acknowledged the wear and tear of the cemetery signs on theatre drive and at the entrance to the cemetery itself. She recommended they be replaced. Proposed by Cowell is a Veterans Memorial Monument to be located within the cemetery and solar lamp posts. These items will be addressed at their next meeting.
