1. **Ordinance 2024-1 An amendment to Ordinance 2020-1, An Ordinance of the Board of Trustees of the Templeton Cemetery District Revising Interment Fees and the Rules and Regulations:** The Trustees will open the meeting to a Public Hearing addressing the proposed revised Interment Fees and the Rules and Regulations.
