Business

1. **The May 2022 Financials:** The Trustees reviewed the May 2022 Financials with Dusi making a motion to approve the Financials as presented. Rillo seconded the motion. Ayes: Rillo and Dusi, Noes: None. Absent: Leon.

2. **TCD Liability Coverage Quotes for 2022 - 23:** The Trustees were informed that the agencies contacted (State Farm, Allstate) were unable to provide said coverage. SDRMA was also contacted and provided a premium of around \$3600.00, however, it would take 4 weeks to approve the limited coverage. Another agency (GSRMA) was contacted. They believe they could provide the complete coverage that TCD originally had with Farmers. The Trustees were provided information of the possibility of being covered under the County of San Luis Obispo. Cowell has been communicating with County Legal Counsel Ben Dore. This contact may prove viable for TCD. The Trustees directed Cowell to postpone committing with GSRMA until all information is received from the county.

3. **Trustee Nick Leon Resignation:** Trustee Nick Leon has submitted his Letter of Resignation to the TCD Board of Trustees. He indicated that due to his pursuit of other venues and activities that are requiring him to travel weekly, he would no longer be available to sit as a Trustee on the Board. Dusi made a motion to accept Leon's Letter of Resignation and the motion was seconded by Rillo. Ayes: Dusi and Rillo.

5. **Trustee Comments:** There was no discussion.

The meeting was adjourned at 4:35pm.

The next scheduled meeting will be July 21st, 2022.
